ORDER:

The following notification shall be published in the next issue of Andhra Pradesh Gazette:-

NOTIFICATION

For the purposes of sub-section (d) of section 2 of the Employment Exchanges (Compulsory Notification of Vacancies) Act 1959 (Central Act No.XXXI of 1959), the offices specified in column (2) of the Annexure hereto are hereby notified as the offices established and maintained by the Government of Andhra Pradesh, in respect of the Scheduled Tribe registrants residing and in respect of vacancies reserved for Scheduled Tribe candidates arising in the Government Departments/Public Sector establishments situated in the district specified in column (3) of the Annexure hereto, for the collection and furnishing of information either by keeping of registers or otherwise, respecting:-

- (i) Persons who seek to engage employees;
- (ii) Persons who seek employment; and
- (iii) Vacancies to which persons seeking employment may be appointed.

These offices shall consequently be designated as Sub-Employment Exchanges for operation of the provisions of the Employment Exchanges (CNY) Act, 1959 (Central Act No.XXXI of 1959).

Under Sub-rule (5) (a) of rule 2 of the Employment Exchanges (Compulsory Notification of Vacancies) Rules, 1960, the Governor of Andhra Pradesh hereby directs that for the purposes of sub-section (1) of Section 4 of the Employment Exchanges (Compulsory Notification of Vacancies) Act 1959 (Central Act No.XXXI of 1959), the offices (Sub-Employment Exchanges) referred to in column (2) of the annexure hereto, shall henceforth be the "Local Employment Exchange", with effect from the date of Publication of this Notification in the Official Gazette in respect of the registrants and vacancies enumerated in the above paragraph. To the extent the Jurisdiction is conferred up the Sub-Employment Exchanges by virtue of this Notification the Jurisdiction vesting in the District Employment Exchanges concerned shall deemed to have been withdrawn.
