ORDER:

In the G.O. first read above orders were issued establishing the A.P.Tribal Welfare Residential Educational Institutions Society on bifurcation from A.P.Residential Educational Institutions Society. Certain number of staff in different categories were allotted to Gurukulam by A.P.Residential Educational Institutions Society basing on the options exercised by the staff members.

The Member-Secretary, A.P.Tribal Welfare Residential Educational Institutions Society (GURUKULAM) has reported that only a few number of staff members were allotted to Gurukulam and as such many number of posts in different cadres have been kept vacant. The Member-Secretary, Gurukulam has requested the Government in the reference 2nd read above to accord permission to fill the posts earmarked for direct recruitment in different categories.

Government after careful consideration of the above proposal hereby accord permission to fill up 50% of vacancies under direct recruitment in different cadres.

Taking into consideration the dire need of teachers in tribal areas and schools which has been met substantially by teachers who were engaged on contract basis

: 2 :

in the past few years, the following dispensation is accorded to contract teachers who have put in satisfactory service and with unblemished record:-

- i) the contract teachers will be accorded age relaxation up to five years in addition to the relaxations given in favour of SC/ST and BCs under normal rules;
- ii) the contract teachers will also be given weightage of 2 points for each year of unblemished and satisfactory service in the Society up to a maximum of 10 points;

- iii) the contract teachers working without B.Ed. qualification shall also be considered for selection. If selected these teachers shall have to acquire requisite B.Ed. qualification within 3 years and till such time will continue as Trainee Teachers drawing only minimum of scale.

The Member-Secretary, Gurukulam is requested to take action to prescribe such other suitable conditions to attract best possible talent and to equip them with best possible teaching skills before declaration of their probation.
