ORDER:

In pursuance of the orders issued in the references 1st and 3rd read above and based on the discussions made in the meeting held by the Principal Secretary, HM&FW on 12-3-2004 with the Principal Secretary (TW) and in consultation with the officials concerned, Director of Health has furnished the proposals for rationalization of the institutions / staff for providing better out reach and delivery of health services in respect of ITDA, Utnoor, Adilabad District.

I. After careful examination of the proposals furnished in the fourth read above the following orders are issued.

(A) The following Institutions shall be converted/upgraded by adjusting the existing staff by redeployment without sanction of additional staff.

1. PHC Bazarhatnoor(V) & (M) upgraded as UPHC Bazarhatnoor(V)&(M).
2. MMU Saidapur(V), Belam(M) is upgraded as a PHC Saidapur(V), Belam(M).
3. Govt.Hospital Tiryani and Subsidiary Health Centre, Tiryani are merged and upgraded as 24 hour Primary Health Centre, Tiryani (V) & (M).
4. Govt. Dispensary, Isgoan and Subsidiary Health Centre, Isgoan(V), Kagaznagar(M) are merged and upgraded as PHC, Isgoan(V), Kagaznagar(M).
5. Govt. Dispensary, Mandamarri and Subsidiary Health Centre, Mandamarri(V) & (M) are merged and upgraded as PHC, Mandamarri(V)&(M).
6. MMU Gadigua, Sirpur(U) mandal is upgraded as PHC Lingapur.
7. MMU Ginnedari, Tiryani mandal is upgraded as PHC Rompally.
8. MMU Sirpur(T) is upgraded as PHC Lonvelly.
9. MMU Chennor, Dandepally mandal is upgraded as PHC Thalapet.
10. MMU Utnoor (V)&(M) is upgraded as PHC Shyampur.

IV. Land along with donations in cash/kind or labour from the local people may be mobilized for establishing/upgrading the institutions.

V. All the posts redeployed/re-designated are all budget posts and the expenditure shall be met with in the budget provision of Health department. Hence there is no additional financial implication towards recurring expenditure.

VI. The Director of Health & Director of Tribal Welfare & Commissioner APVVP shall take necessary action accordingly.

VII. The Jurisdiction of PHCs(Annex.) may be revised by P.O/ITDA/Dist.Collectors only if such revision contributes to better access to the people or coverage of villages/-sub-Centres. Depending on the number of Medical Officer's, staff and the need, PO's of ITDA in consultation with DM&HO and with approval of Dist.Collector shall declare PHC's as may be required as, 24 hour PHC's, and supplement the posts wherever required by re-deployment/re-designation of equivalent posts in terms of orders issued vide reference 3rd cited.
